GCV Website Update

Grand Champions Villas website (grandchampionsvillas.com) has been updated, with the most current and up to date documents, including meeting minutes, financial info, newsletters and more.

High Speed Internet Service

If you are in Maui right now, you will have seen Hawaii Telcom's trucks on Wailea Ike and Grand Champions bringing high speed, fiber optic cables into our complex. We will soon be notifying you as soon as the schedule for each individual unit has been set.

The plan is to install the Optical Node Terminal (ONT) and Residential Gateway (RG) at the entry point of each unit, which in most cases will be on the interior wall right behind the unit's television set. This will in turn provide Wi-Fi service covering the entire unit without the need for additional cabling, moldings etc.

Please be sure to sign the waiver that was mailed to you and return it to the office, so the technician can enter your unit at the time of installation. I believe we will all be very pleased with this more reliable and much faster internet service once it is installed.

Category Three Remodels

Each year, from December 15th through April 1st, category three remodels are not permitted.

Category three remodels include carpentry, tile etc. All category three remodels require approval by the GCV office before starting.

Manager's Report

Painting Update: There is new paint on about 1/3 of our lanai and entry railings, which makes a notable improvement. This project is moving along smoothly. It is important to routinely clean your lanai rails or the Maui dirt will eventually penetrate and permanently stain the paint. Also, if you suspect that there is dry rot on your lanai, please report this to the office immediately to prevent major damage.

Tile replacement at the exterior entries and landings to the upper floors is approximately 25% complete. It looks like we will exceed our goal of completing 50% of the complex this year; we will complete the remainder of this tile project next year between April and December.

This year we are replacing all of the street lamps with LED lamps. Utilizing the existing fixtures, we are able to retrofit an LED "Lucy Lamp", at a fraction of the cost (thanks to Lee Sanders, fellow GCV owner, for the prototype). We will also replace all of the entry and sidewalk bulbs with LED bulbs by the end of this year, which should bring more light at a lower cost.
